Happy Easter Vineyard pastors and staff:

For this holiday of the Feast of Easter and the Resurrection, I am writing for assistance and prayers for my son. My previous multiple prayer requests to the Vineyard Church have not produced any response or contact of any communications from Pastor Greg and the Care Team. Shane mistakenly responded to one email written for my son and was blind copied to VCKC pastors and Care Team.

I have no contact with my son, so my email message to my son could have been communicated to him by anyone at VCKC who was blind copied on the numerous emails I sent him. I presume no one was considerate enough to have empathy for my son to let him know his father sent him emails. What you may be told about my son's relationship with me and what is truth may be different. Psalms 69:4-5.

I fail to understand what appears to be passive aggressive response from pastors and the Care Team to my prayer requests for my son, and to stop the child abuse he experiences. You may have no idea of the truth of what he experiences. Question what you are told. Seek the truth through prayer. Help stop child abuse at the VCKC. Look for the signs. Research to know the signs of abused children.

God have mercy on my son. One may have no idea of what he experiences and suffers outside of the Vineyard Church. I do not know if my son is still at VCKC. My son may be removed from the VCKC after any discovery of the truth creates a narcissistic injury. I hope my son is still worshiping at the VCKC and hopefully is allowed to play guitar for services.

Again, I ask for prayer and assistance for my son to end the parental alienation child abuse. I sincerely thought Pastor Greg would seek the truth, hear the truth, and see the truth instead of believing the lies. These lies hurt my son. Psalm 38:19.

How would each of you feel if you were alienate from your children. How would your children feel about parental alienation child abuse. Please find empathy for my son and stop this child abuse. One would wonder why Pastor Greg would allow this parental alienation and emotional child abuse in his church.

My prayers are that one would, after reading this letter, give my son their phone and assist him to call his grandmother. Or maybe assist my son to call his dad.

Where is the Christianity and empathy for a child, because no one has yet bothered to help my son and stop the child abuse. My son is abused and the Vineyard Church has done nothing to stop the emotional abuse and parental alienation. The Vineyard Church North and Pastor Greg has bought scandal and reproach to this organization. Pastor Greg is a great speaker and preacher, yet one would wonder where is the Christian actions for children in the church.

My word I try to keep. All communication with the VCKC are documented and published on the internet webpage vkc.faicourts.net. Do whatever you can to help stop the child abuse of my son. I write legislation and hope to help children with statues.

Contact me anytime 24/7. Help my son to call his father and start a reunification process after almost two years since we have seen each other. I fear that my son will be removed from the church when the awareness of the deceptions come to the light.

Thank you for allowing and blessing my son with his guitar playing with the church. I tried to teach my son guitar for many years, and now he is a better guitar player than his dad. My son sounds very good. I love him very much.
