Hello Son:

I hope and pray you are doing well. You looked good at the parade. Amazing that we have not seen each other in almost 2 years, and we ended up seeing each other, both of us being in the same parade. That is God at work. I saw the your guitar first as your float entry pasted by us politicians. I was not sure that the guitar I saw on the float was a Gretsch Silver Jet. So I walked fast up to the float and saw it was a Gretsch – and then I saw it was you playing. You look good, and sound good. What a miracle for both of us being in the same parade. You won the parade music award too. Cool!

It is still saddening that the Vineyard pastors and staff still condone child abuse of parental alienation. This is the number one child abuse in America. Your suffering from the many abuses has bought me to politics and writing legislation.

I am on the ballot for elected office. Also, I am now a graduate of the Learning Institute for Campaign Strategy. I never thought I would be in politics. But, this is about the only way to help abused children.

I cannot believe that the pastors, or anyone working at the VC, would allow this abuse and violation of the 5th Commandment.
